

CLARIFICATION ON PERSONAL DATA PROCESSING

As Global Communities Inc. Türkiye Temsilciliği, protection of privacy, protection of information security and respect for ethical values, especially the protection of fundamental rights and freedoms are among our primary principles. In order to fulfill the obligation of clarification arising from the Article 10 of the Law on Protection of Personal Data (“PDPL”) of our Association, which has the title of Data Controller within the scope of the PDPL No. 6698, our explanations below are presented for your information. The concept of “personal data” in this document has been used to cover special personal data.

Purpose of Processing and Transferring Personal Data

Your personal data in the personal data categories below are collected by our Association and processed in a physical or electronic environment for the purposes of managing secretariat processes such as association board meetings, general assembly meetings, arranging the signature circular, power of attorney, business directive etc. and using them in business processes, preparation of annual report of the board of directors, preparation and submission of periodic financial reports, representation of the association on different platforms, carrying out the processes carried out in public institutions and organizations, establishment and execution of contracts, using in applications to be made in accordance with the relevant legislation, especially the Associations Law No. 5253 before the relevant official authorities.

- Identity Information (name surname, T.R. identity card, passport or driver's license and information contained in these documents, your profession)
- Contact Information (your phone number, address and residence, e-mail address)
- Legal Transaction Information (your signature, date of appointment to board membership, etc.)
- Finance (Attendance fee, etc. payments made from the association based on your board membership)
- Other Information (Other personal data required by the Membership of the Board of Directors will be collected where necessary.)

Your personal data, such as banks, suppliers, business partners, public institutions and organizations, association directorates, legal counselors and lawyers etc. with whom we have a contractual relationship in order to achieve the above mentioned purpose. Data security can be shared with real and legal persons and necessary precautions can be shared by our Association and published on our website if necessary.

To the extent necessary for fulfilling our obligations arising from the law and our Association policies, fulfilling our internal audit, risk management and reporting obligations, and our legitimate interests and for the fulfillment of the legal obligations, provided that they do not harm your fundamental rights and freedoms for the purposes of conducting administrative affairs and Association activities, your personal data is shared with

- Public institutions and organizations
- Companies that we receive services and consultancy (company where we receive information technology support, etc.).

Personal Data Collection Method and Legal Reason

Personal data are collected, used, recorded, stored and processed within the framework of the principle of proportionality, in connection with the legitimate purpose set out above, in accordance with the law and honesty rules, by giving direct consent to the personal data holders by our Association.

Your personal data is processed within the framework of the following legal reasons stated in Article 5/2 of the PDPL:

- a) Clearly prescribed by law
- b) The processing of personal data belonging to the parties to the contract provided that it is directly related to the establishment or performance of a contract,
- c) Mandatory for the data controller to fulfill his legal obligation
- d) Data processing to be mandatory for the establishment, use or protection of a right
- e) Data processing to be mandatory for the legitimate interests of the data controller, without prejudice to the fundamental rights and freedoms of the person concerned.

Your Rights and Contact Information in accordance with Article 11 of the PDPL

In accordance with article 11 of the PDPL, you have the right to obtain information about your personal data by contacting Global Communities Inc Türkiye Temsilciliği.
