Your personal data is based on the purpose of providing communication when necessary and providing fringe benefits to our employees due to the rental agreement and rental relationship concluded between you and our employee. Your personal data, KVKK m. In accordance with clause 5/2 (c), it is based on "the data controller's fulfillment of its legal obligations" and in accordance with clause (f), "data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the relevant person". Your personal data is shared with legal authorities only if necessary, based on the same purpose and legal reasons.
